# Who We Are and Our Purpose

Modeled after similar organizations in other states, Grass Roots South Carolina is a joint project of Mid-Carolina Rifle Club and Gun Owners of South Carolina. Our primary goal is to protect the rights of law abiding citizens who have chosen to obtain concealed weapons permits.

Our main effort is in educating merchants who post against concealed weapons. Our operating protocol is included in this newsletter and explains how our organization works. Briefly, we initially contact merchants who have posted signs against concealed weapons and attempt to educate

them. Afterwards, we hope that they will either remove their signs or post an alternative sign which we provide. If they do neither we distribute the name of the business to thousands of South Carolinians via gun clubs, hunt clubs, shooting sports associations, business supporters, wildlife groups, the Internet, and any other available means encouraging a voluntary boycott until the signs come down.

We have had cards printed for those of you that want to report businesses that are posting signs against concealed carry permit holders. Also, we have already launched notice of our organization in several firearms related newsletters, concealed weapons classes, as well as publicly to outline our goals. The idea is to make this a true grass roots effort in organization from our end as well as the public's. A web page has been constructed and is available for public browsing. The page includes legislative updates, a large Second Amendment Library, and information on how to support GRSC as well as a listing of those retail establish-ments that post against concealed weapons permit holders.

If you are interested in being a part of this effort and would like more information regarding this grass roots effort please contact us we will place you on the supporter list. Also, we need to build the database of those businesses which have been spotted by our supporters with "no carry" postings. If you have seen such a business please mail us and let us know so we can initiate correspondence with them to change or remove their signs. With your help we can succeed.


Here is how the system works and how you can help:

- 1. When you encounter a business which posts, politely ask for the manager. Explain that they have nothing to fear from permit holders, that they have in effect posted an open invitation to armed robbery, endangered your safety, and that you will not spend money in their establishment as long as they prohibit concealed carry. You may add you intend to turn their name into GRSC for addition to the boycott list.
- 2. Obtain and send to GRSC the COMPLETE business name, address (including zip code), phone number, and name of the manager or owner.
- 3. Although we will accept the information from anyone, in any format, we ask you to use GRSC "Don't Buy" Cards for this purpose. These are wallet-sized cards, half of which you give to the merchant to notify them of the items in (1) above. The other half contains blanks for information on the business. Fill it in and send it to us. The "Don't Buy" cards have the advantage of demonstrating to the business that they are being subjected to an organized boycott rather than a small scale, piecemeal effort. Information on obtaining cards is below. Please help us out by ordering the GRSC "Don't Buy" cards.
- 4. GRSC will send the merchant a letter explaining our position in a non-threatening and tactful manner. The letter will point out that the merchant has made himself a target for robbery as well as increased the danger for every customer that shops at their business. Also contained in the letter will be one of our alternative window stickers that states, "No firearms allowed except by law enforcement and duly licensed permit holders."
- 5. After receiving our letter we will check back with the merchant to see if they have removed the "No firearms allowed" signs or replaced them with our signs. If they have, then no action is taken. If they do not comply, the merchant is notified that they will be boycotted. They will also receive instructions on how to get off the GRSC "Don't Buy" list.
- 6. We will compile the list of businesses, update it monthly, and distribute it via gun shops, gun shows, concealed handgun classes, the Internet, fax, wildlife clubs, and all other available means.
- 7. We will monitor businesses which remove signs for "cheating." Any merchant who cheats by returning signs after advising us of removal will be subject to a mandatory one year boycott.
- 8. Don't buy from merchants who post! This effort will succeed only if we make it hurt!
- 9. Help distribute the list of boycotted merchants, and the "Don't Buy" cards to others. Make sure all of your friends have at least one card with them at all times.
- 10. Cards are free! However, to help defray our costs we ask that you consider a small donation. Even a few dollars will help. Make checks payable to MCRC and put GRSC in the memo area and mail to:

Did you know .

In 1982, Kennesaw, Georgia, passed an ordinance "to provide for the civil defense of the City of Kennesaw, and further in order to provide for and protect the safety, security and general welfare of the City and its inhabitants." The ordinance states that "Every head of household residing in the City Limits of the City of Kennesaw is required to maintain a firearm, together with ammunition therefor," except criminals, persons with moral or religious objections, and those mentally or physically incapacitated.

Firearm ownership rates were not expected to change in Kennesaw after passage of the ordinance; most households were presumed to have firearms. Instead, it was expected that publicity surrounding the ordinance would warn criminals that residents were capable of protecting themselves and their community and would do so with the government's blessing. Between 1981-1985 violent crimes in Kennesaw dropped 71%; burglaries dropped 65%. Between 1981-1993, though Kennesaw's population doubled, burglaries dropped 16%.

After learning that South Carolina's Department of Labor, Licensing, and Regulation was providing "No Concealed Weapons Allowed" stickers at public expense to merchants, a letter was sent to Lewis F. Gossett, Director of LLR. The letter expressed displeasure at what seems to be an undermining of the Law Abiding Citizens Self Defense Act by none other than a Department within the South Carolina Government!

After you read their response, perhaps you would like to fire off a letter educating them on the differences between "law abiding citizen" and "criminal." Obviously they haven't read the Lott Report! Their response follows:

Thank you for your inquiry related to the concealed weapon signs provided by the Department to businesses. I would to take this opportunity to explain how and why the department is involved.

The Citizen's Self-Defense Act of 1996 gives businesses the right to decide not to allow concealed weapons on their property. The Department was asked by the S.C. Chamber of Commerce to make available a poster to businesses who elect not to allow concealed weapons on their premises. The text of the poster was written by the Chamber's attorney and does not bear the Departments name.

Even before this request was made by the Chamber, one of the Division of Labor's responsibilities has been to distribute posters required for posting on issues such as job safety, wages, and child labor. As the enforcement agency for OSHA in South Carolina, we have a concern about violence in the workplace. Experience has shown that violent acts occur when someone brings a weapon into the workplace.

, rest assured, the Department's role in concealed weapon signs is not an attempt at undermining the Citizen Self-Defense Act of 1996. We have been able to accommodate a request from business that is within the framework of the Act, while also taking a preventative measure in work place safety.

#### WORDS OF WISDOM

Compromise? It's regrettable the word compromise has been so convoluted, because there are two basic kinds, often incompatible with each other. One is a physical compromise, the other, one of principle.

Let me give several examples. My wife and I want to go to a movie. She wants to see a love-'em-up and I want to see a shoot-'em-up. We compromise and pay to see a comedy. My buddy and I are going hunting together. He wants to eat breakfast at the Road Kill Cafe and I want to dine at Mae's Country Kitchen. We compromise by eating at one on the way and the other coming back.

There is no real principle involved in either example, each of us might be put out a bit by not getting their own way but no harm occurs to either one's principles. "Giving in" and taking others into consideration is a proper attitude for harmonious relationships; we all do it constantly. There's not a marriage that can last more than two weeks if multitudinous physical compromises aren't made by both sides.

Physical compromise is a necessary good, often the mark of an understanding and gentle person.

On the other hand, compromising principle is another matter. Allowing oneself to be trapped into bargaining away rights is destructive to character and should be viewed as utter foolishness. When an anti-gun legislator presents a bad piece of legislation and then offers to water it down, he's not really compromising now, is he? We must always ask,

exactly what is being compromised? What is he giving up? That legislator first asks for 100 percent of our rights and then, through negotiation, takes only 10 percent. He may have compromised his original request, but we have forsaken principle by giving him that 10 percent.

If a thief sticks a gun in your ribs and demands your wallet, then decides, good naturedly, not to keep your credit cards and the pictures of your kids, no compromise is involved. He may be personable, even polite, but still a thief and you, the victim.

When the legislature decides to steal some of our rights and plans to use police force to accomplish it, what's the real difference between them and the thief? Darn little!

They hide behind the excuse that they're legislating democratically. The fact they do it by a majority vote has no moral significance whatsoever. Numerical might does not constitute right, no more than a lynch mob can justify its act because a majority participated.

Democratically, we elect men and women to office but we have to ask ... to do what? To abrogate our rights? Restrict our freedom? Destroy our ability to protect our lives, family and property? The answer is a resounding NO!

We elect representatives to uphold the Constitution and to protect our rights, not to negotiate them away in the name of compromise and democracy. Our forefathers understood that certain rights were inalienable, God-given, untouchable by mere men. That's why they delineated these uncompromising principles in the Bill of Rights. They weren't kidding when they said it was necessary to "bind men down by the chains of a Constitution."

We, at Gun Owners of America, are often asked why we aren't more amenable, willing to compromise.

Our answer is that we are always willing to make concessions that are physical, but not of principle. When we politically compromise and allow anti-gun leg-islation to pass, no matter how insig-nificant it may appear to be, we have abdicated our responsibilities. Abdication is the work for surrendering our principles legislatively. Honor binds us to resist with all our might.

It is our duty to oppose ANY AND ALL attempts at watering down the principles embodied in the Second Amendment.

We are obligated by principle to vigorously oppose any move that diminishes the same freedom enjoyed by our fathers.

There are those in the gun movement who call out for pragmatism, bipartisan cooperation and dialogue with our opposition. It has been tried for decades and what has been our reward? Lost ground. Retreat. A few crumbs from the table. Many gun owners have been victims of their own decency, believing some hope exists in dealing with our implacable enemies. They have been intimidated by the names we are called when we refuse to abdicate our rights.

It's a mortal sin when a gun organization caves in and justifies any loss in the name of compromise. It's not com-promise, it's abdication pure and simple; let's call it by its real name . . . abdication.

We should all concentrate on regaining the ground we have lost and begin by not giving another fraction of an inch. For those of us at Gun Owners of America, retreat is over.

#### GRSC Book Review

### "UNINTENDED CONSEQUENCES" - A Review

Forward: I would like to offer thanks to Bill Krupicka for recommending this and other fine works.

[Analysis] If you're looking for a riveting novel written by an author who loves firearms, shooting, and the American vision of freedom, Unintended Consequences is for you. Written by John Ross, whose previous writings include Self-Defense Laws and Violent Crime Rates

in the United States and technical articles for Machine Gun News. the book centers around the twentieth century history of what Mr. Ross correctly dubs "the gun culture."

Tracing the roots of federal abuses, the novel begins in earnest with the United States government's deadly suppression of a group of military veterans known as the "Bonus Marchers" during the depression. It then puts faces and personalities to the inception

of the federal government's first gun control legislation - the National Firearms Act of 1934.

Unintended Consequences is at its most winning, however, as it traces the life of Henry Bowman. Born in the 1950's, he grows up in the gun culture. As a youth who loves and is highly proficient with firearms, Bowman matures during the era of increasing governmental intrusion into the lives of American citizens. Through his eyes, you experience the full implications of federal gun control legislation, particularly the Gun Control Act of 1968.

As a political activist and licensed machine gun dealer, Bowman inevitably becomes ensuared in the violent abuses of the Bureau of Alcohol, Tobacco and Fire-

arms and is forced to fight for his life. The twist which follows neatly answers those who tell us that an armed citizenry is an no longer capable of balancing a modern military.

Along the way the author reveals profound love and knowledge of firearms, describing in intricate detail long range riflery, big game hunting, military weapons, and feats of

> marksmanship. People like John Browning and Elmer Keith figure prominently in this book.


> No doubt the fans of Diaries

> governmental power whom we incorrectly label as "liberals" will consider this novel a prescription for rebellion. When it can no longer be ignored, they will label it "extremist" and liken it to works like The Turner

But those accusations will have nothing in

common with Unintended Consequences. Rather than delving into conspiracy theories, anti-semitism, or other examples of fashionably-reviled extremism, Ross merely advocates federal recognition of our basic civil rights especially the Second Amendment. He likens recent federal abuses to the irrational and avoidable chain of tragedies which led to World War I, concluding, "It is my hope that this book will reduce the likelihood of armed conflict in this country."
